4. The program has been granted accreditation for further 3 years. **Sarojini Naidu Vanita Pharmacy Maha Vidyalaya H. No. 12-5-31 & 32, Vijaypuri Colony, Tarnaka, Secunderabad-500017, Telangana** should submit fresh online application under First Cycle SAR January 2016 document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Sarojini Naidu Vanita Pharmacy Maha Vidyalaya H.
