Summary

The Guest Speaker for the webinar is Mr.Mohammad Raheem, Quality Compliance Manager Julphar Gulf Pharmaceutical Industries, UAE.

The program started at 11:00 am with the welcome address by Principal Dr.V.Jyothi and followed with the address given by Dr. N. Srinivas, Director, and SNVPMV. The session started with prayer song and introduction of college facilities by Dr.T.Mamatha. The guest speaker, Mr.MohammadRaheem, was introduced and invited for the session by the student Aakanksha of Pharm.D III year.
