# **Report on Medicover Hospital Training**

In order to have the knowledge, to have new experiences in the field of health care, the Sarojini Naidu Vanita Pharmacy Maha Vidyalaya students of Pharm. D underwent training at Medicover Hospital pharmacy. This training course is extended over a period of 1year beginning on 16 February 2022 and ending on 16 February 2023.

The main objective of this training is to

- Observe, compare, analyze and comment on the management of different pathologies, clinical and paraclinical approaches.
- Medication errors & adverse drug reaction reporting
- Patient education & counselling,
- Prescription monitoring
- Pharmacokinetics & therapeutic drug level monitoring
- ➤ Integrate fully the family medicine service (go to the extended clinic, the ward, the emergency room), participate in the activities of the other services.
- Observation of procedures
- Rotations in family medicine, internal medicine, paediatrics, obstetrics and gynaecology, surgery, especially paediatric and adult emergencies.
- > To professionalize the functioning of the pharmaceutical services in hospitals.
- > To ensure availability of the required medication at an affordable cost at the required time.
- > To plan, organize and implement the policies of the pharmacy.
- > To perform functions of management of material, purchase, storage of essential items.
- > To maintain strict inventory of all items received and issued.
- To counsel the patient, medical staff, nurses and others involved in patient care on the use of drugs, possible side effects, toxicity, adverse effects, drug interactions etc.
- > To serve as a source of information on drug utilization.
- To manufacture drugs, large/ small volume parenterals which are critical for use in patients.
- To participate in and implement the decisions of the pharmacy and therapeutics committee.

- > To organize and participate in research programmes, educational programmes.
- > To provide training to various members of the patient team on various aspects of drug action, administration and usage.
- > To engage in public health activities to improve the well-being of the population.
- > To interact, cooperate and coordinate with various other departments of the hospital.

This is a phase of training wherein a student is expected to conduct actual practice of pharmacy and health care and acquires skills under the supervision so that he or she may become capable of functioning independently
