Organization-wide awareness and undertaking on policies with zero tolerance

The institution has a well-defined policy for the points to be covered under "Zero tolerance" the process and procedures are detailed below.

The policies under zero tolerance will be informed to the students during the student orientation programme, annual day every year.

(a) Prohibition of Ragging in Educational Institutions Act26, 1997 and Disciplinary Act:

- Prohibition of Ragging within or outside educational institutions.
- Without permission no entry is allowed within the college and hostel premises.
- It is compulsory for all students to carry identity cards and need to show on demand.
- Girl students must be available in hostel rooms by 7 pm.
- The Hostel Wardens can inspect the rooms at any time.
- Before leaving the hostel, it is necessary for a student to submit declaration from parents to the warden.

(b) Detention of students from Internal and External Examinations:

• Students' Attendance in the classes must be maintained above 70% for internal examinations Mid Term Examinations (MTE-I and MTE-2) separately.

(c) Reporting of Teaching and Non-teaching staff members:

• Every teaching and non-teaching staff member must do biometric attendance.

(d) Grievance submission and Redressal:

- Grievance Form submitted to the concerned section in charge in writing as per format.
- Action taken report must be submitted within the stipulated time for the closure of the grievance.
- Information about the action taken must be communicated to the individual within the stipulated time.

(e) Faculty Appraisal:

- The Office Superintendent maintains Academic Performance Indicators (API) files of every faculty member.
- Faculty members have to submit his/her Appraisal Form at least 15 days prior to the date of increment.
- Faculty Appraisal Form carries a weightage of 200 score points focusing on teaching and learning, research, innovation along with career advancements with respect to various activities.
- Faculty members must have at least 50% score points to get annual appraisa

 OR ANNOYANCE OR FEAR OR APPREHENSION OR THREAT OR INTIMIDATION OR
 OUTRANGE OF MODESTY OR INJURY TO A STUDENT.
