Hence SNVPMV and MASTERS would like to enter into a Memorandum of Understanding for collaboration and co-operation in various activities as mentioned above within area of Skill Based Training, Education and Research.

# NOW THEREFORE, IN CONSIDERATION OF THIS MEMORANDUM OF UNDERSTANDING (MOU), THE PARTIES HERETO AGREE AS FOLLOWS:

#### **1. CO-OPERATION:**
