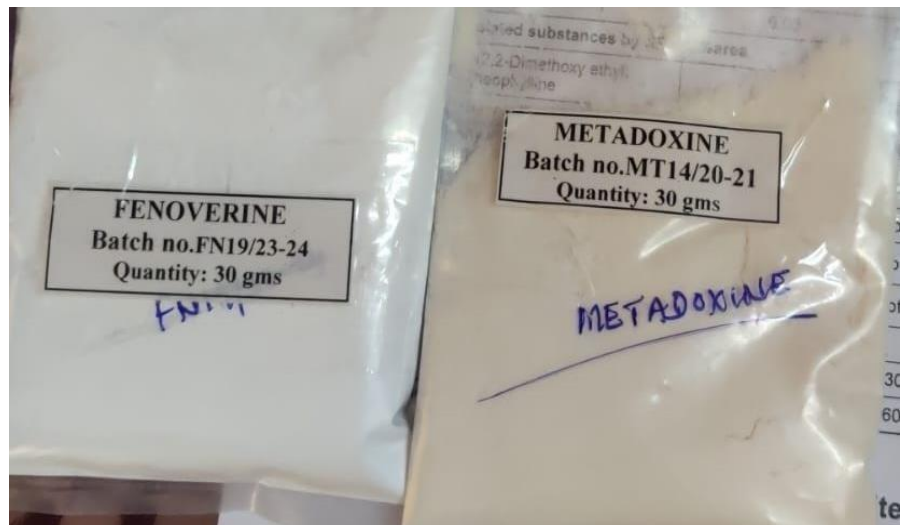

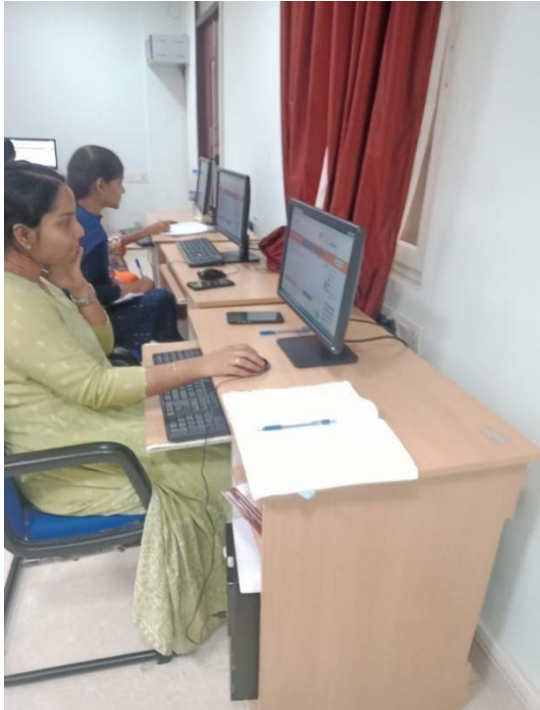

Sarojini Naidu Vanita Pharmacy Maha Vidyalaya (Sponsored by The Exhibition Society) in association with Indian Pharmaceutical Association, TS branch has organized a guest lecture on the topic “**The DNA Editing Technology** on 14th September 2022, 11:30 am. The Guest Speaker for the lecture was Dr. Neeradi Dinesh, M.S. Pharm., Ph.D, Research Scientist, CSIR-CCMB, Hyderabad.

For this guest lecture, the numbers of participants attended were about 280.

The program started at 11:30 am. Dr. Hyma started the program and invited all the dignitaries onto the dias. Dr. B. Prabha Shankar, President IPA, TS branch and Chairman, SNVPMV, delivered a welcome note and addressed the session by cordially welcoming the guest speaker, of the guest lecture, Dr. Neeradi Dinesh.

At 11.50 am Dr. Neeradi Dinesh, started the session on the topic “The Exciting Field of DNA Editing Technology (CRISPR – CAS9)”. During the session, Sir interacted with the students and gave a quick recap on the basic concepts of the cell that a human body is made up of 30-37 trillion cells and each and every cell carries all the genetic information. He also imbibed the knowledge of the DNA, genes, 20000 genes distributed in 23 pairs of chromosomes. The participants were enthusiastic and were listening with extreme intrigue as the session was informative and thought provoking.

With supreme knowledge and experience, Sir has explained on the genetic engineering technology by giving three examples which include 1) Insulin production in the past using pancreas of animals like pigs or cattle and at present using bacteria like *E.coli* which has saved the lives of many animals; 2) Introduction of Luceferase genes (fire fly genes) into Tobacco plant, which made tobacco plant to light and 3) Development of *Bacillus thurangienses* (Bt)

cotton crop which has resistance against the boll worm infestation in the crop which otherwise destroys about 70% of crop yield.

Sir gave an insight on the CRISPR-CAS9 technology which means Cluster Regularly Interspaced Short Palindromic Repeats - Crispr associated protein 9. CRISPR technology allows us to selectively delete a gene and CRISPR-CAS9 technology is the latest technology to introduce a specific gene into the required DNA of the cell. This technology can be used in the treatment of many diseases like Thalessemia, Cancer, Sickle cell anaemia, Haemophilia, Cystic fibrosis etc. He proudly said that the first Thalessemia patient treated with CRISPR technology was on November 20, 2019 where the patient is totally cured from the disease.

Further, Sir emphasized on the applications of the CRISPR technology in IVF, production of stem cells, retinal cells and also in the treatment of various hereditary disorders like diabetes. He finally explained the limitations of the technology and concluded the seminar by giving the future scope of the topic and encouraged all the students to find their future in a different and exciting area like DNA editing technology.

At the end of the session, Sir encouraged the students to put out all their queries regarding the topic. Students were very enthusiastic and asked various questions on the topic. Many doubts were also raised by the audience not only from the students but also from the faculty and members of Exhibition society and managing committee members, Exhibition society, Nampally Hyderabad. Most of the questions were patiently answered by sir, and left few to be answered by the Chairperson, of the session making the session, both informative and interactive. It was overall, a very excited, novel and interesting session to all the attendees.

REPORT ON INDUSTRIAL VISIT

TO

CLINSYNC CLINICAL RESEARCH PVT LTD

Date & Time of Event – 19th March 2020, 11:30 am

Industrial visit is important in the career of a student especially in professional degree. Sarojini Naidu Vanita Pharmacy Maha Vidyalaya, College for Women, (Sponsored by The Exhibition Society) organized an industrial visit for M.Pharm students of all branches to provide an insight into the internal working of companies. ClinSync Clinical Research Pvt Ltd is a clinical research organization located in Madeenaguda, Hyderabad. About 14 M.Pharm students and 4 faculty visited the company on the day.

All the students and faculty reached the company at 11.20 am and registered the names at the reception area. We are instructed to place the phones in silent mode and then was accompanied into the company at 11.30 am. Dr. Sanjay Wajid, Head of Pharmacology department gave an introduction about the company. He explained briefly about pharmacology, importance of testing the drugs for safety and efficacy. Dr. Sanjay elucidated about comparison of test drugs with standard drug for generic drug development, different designs used for the study such as parallel design, crossover design in bioequivalence studies. He clarified that the company mainly conducts efficacy tests through bioequivalence studies in healthy human volunteers. He explained that the actual process of clinical research starts with collection of volunteers, their registration, taking consent from them, screening the volunteers for their health to check whether they are suitable for the study and prior informing them of the date of commencement of study.

Dr. Sanjay mentioned that on the day of study the volunteers will be explained about the study, risks involved during the study and their willingness for the study will be recorded visually with their sign, date and time. He further described that one day prior to the study the volunteers are given uniform, ID cards, subjected them to either 10 hours fasting study or fed study by giving high fat and high calorie food, administering the test, deciding the sampling points based on C_{max} and T_{max} and collection of blood sample after suitable intervals. He explained that any adverse event during the study should be treated whether it is related to the drug or not and given compensation accordingly if any abnormalities or deaths occurs. Dr. Sanjay clarified that to conduct any procedure during the study standard operating procedures should be followed. We are then guided to different areas in the company such as volunteer registration area, volunteer waiting area, sample collection point, ECG room, Investigators room, ICU, Pharmacy, wards, bioanalytical area, dosing and vital station, sampling process area, storage area, washroom. Dr. Sanjay explained that all areas in the company have access control, ICU have 12 beds, wards have 160 beds and sodium monochromatic light fixed to check for any light sensitivity. He mentioned that the drugs come to the pharmacy, stored in controlled environment, placed in individual containers, collected from these containers when required. Dr. Anuradha, Dr. Praneetha, Dr. Harika clarified their queries with Mr. Sanjay after the session.

The first department that we visited was raw material and packaging material warehousing area where we got to learn how the raw and packaging materials are stored and labeled indicating its batch number, lot number, issue date, expiry date, retest date, and storage conditions. Then we were taken to dispensing area where we got to know about the procedure for dispensing of raw and packaging material according to given MRO (material request order) provided by production area.

The next area we visited was washing area where different equipment was washed according to developed cleaning procedure, we were informed about cleaning and validation procedures. After that we visited production department, in that granulation area where we saw different granulation equipment such as rapid mixer granulator, fluidized bed drier, different steps used during granulation such as shifting, sizing, drying etc. After visiting granulation area, we moved towards compression area, where we saw compression machine, he explained about different parts of compression machine like stations, tooling, hoppers, and feeders. The next area was capsule filling area where we got to know about different types of fillings like powder, granules, pellets, and mini tablets that are being filled in capsule shell and polishing. We next visited the AR&D department and saw several analytical instruments

We started our journey at 9:00 AM from college and reached our destination at 11:30 AM. We divided our students in the batch of 23 students per batch for the visit and the interaction with the industry person. A brief introduction about industry was given by Manager of company. Firstly we were taken to gowning room and provided with gowns and caps, several posters were there instructing proper gowning procedure. The first department that we visited was raw material and packaging material warehousing area where we got to learn how the raw and packaging materials are stored and labeled and we have seen different types of labels with different colors fixed on containers indicating its batch number, lot number, issue date, expiration date, retest date, and storage conditions. They were using in-house software for digital data maintenance. We were also informed about SAB system which they are going to use in future for warehousing data maintenance. Then we were taken to dispensing area where we got to know about the procedure for dispensing of raw and packaging material according to given MRO (material request order) provided by production area. The next area we visited was washing area where different equipment were washed according to developed cleaning procedure, we were informed about cleaning and validation procedures. After that we visited granulation area where we saw different granulation equipment such as rapid mixer granulator, fluidized bed drier. Furthermore, we were also informed about different steps used during granulation.

such as shifting, sizing, drying etc. Different types of granulation process were used like wet granulation and dry granulation. Meanwhile we got to know about how the sampling has been carried out for dissolution test and what different kind of analysis techniques they were using. After visiting granulation area we moved towards compression area, where we saw compression machine where he explained about different parts of compression machine like stations, tooling, hoppers, and feeders. He also explained about different defects of tablets due to compression variation and its remedies and whole procedure for compression was explained in detail. The next area was capsule filling area where we got to know about different types of fillings like powder, granules, pellets, and mini tablets that are being filled in capsule shell, then the next step explained after filling was polishing. After filling area we have seen the coating area where he explained that coating is the most crucial step in tablet manufacturing two coating equipment. He gave us details about fluid bed equipment used for the coating of pellets and granules. The whole coating principle was described in detail. Then we head towards packaging area, the whole packaging area was divided into two parts like primary packaging area and secondary packaging area in primary packaging area different packaging systems were there like blister packaging and bottle packaging, the bottle packaging was in process so we informed about the procedure in detail, we learnt about how the packaging material is selected and tested for its appropriateness and in accordance with the foreign market requirement for the packaging and labeling. In blister packaging area the process used for blistering was semi-automated. Brief information was given about the secondary packaging of the tablets and capsules. Then we moved to QC Department and we have seen various analytical instruments like WATERS-HPLC, TOC, Atomic absorption spectrophotometer, furnace, stability testing chambers for long term, real time and intermediate analysis and also observed various sampling procedures. In this visit students were very eagerly waiting for listening to industrial higher authorities. The technical head of Mars therapeutics.Ltd. conducted very informative session for the students and also be motivated to the students to select their domain and area of interest. He also guided the students to select the areas like QC and production and software for testing etc. and its importance in the current market.

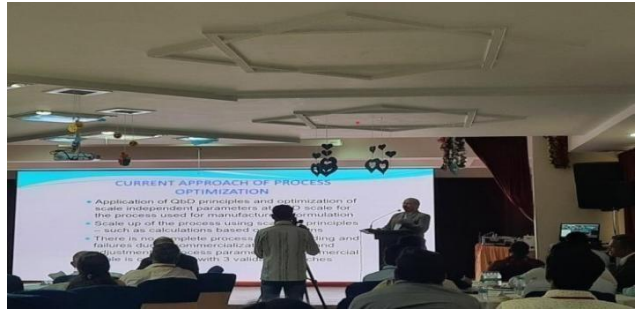
Sir introduced the guest speaker, Dr. V. Venkateswarlu, Managing Director, Neuheit Pharma Technologies

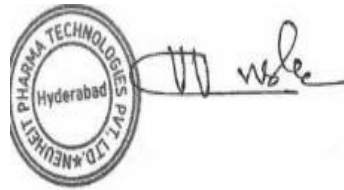
