Report on Industrial Visit

Topic: Industrial Visit to Vivimed labs, Jeedimetla

Date: 03-01-2024

Time: 10:00AM to 1:00PM

The college organized an Industrial Visit to Vivimed Labs, Jeedimetla on 3rd January. The company is a cGMP facility for the manufacturing of Tablets, Capsules, Liquid orals and ointments with 9 departments like, production, quality control, quality assurance, formulation research and development, engineering, maintenance etc. M.Pharm I semester student, 4 students of Pharmaceutical analysis, 6 students of Pharmacology and 10 students of Pharmaceutics department visited the industry.

The students first observed the liquid manufacturing and packing section, starting from sugar syrup preparation to packing of bottles in shippers. The capacity of syrup preparation, holding tanks was 5KL. Decartoning of bottles, washing of bottles by air, cool water, hot water and drying was observed. 10 bottles are under cleaning at a time. Then, filling of syrup, capping, sealing, optical check, labeling, labeling rejection, secondary packing into cartons were also carefully observed. The students clarified their doubts regarding temperature, humidity maintenance, recording, status labels etc. Students also gone through BPR of a product and details of IPA checks during the process.

In the storage section, receiving area, quarantine area, under test area, approved area, rejected area, separate dispensing facilities for active materials & non-active materials were observed. The documentation practices for all these operations were also explained by the respective personnel of the industry. Solvent storage area maintenance was clearly explained with an example of isopropyl alcohol.

Tablet production area was visited by the students and they observed different operations like, wet granulation, sifting, drying in FBD, blending, compression and blister packing. Different controls in all these operations were carefully observed and doubts were clarified at each stage.
