Constitution of the Anti-Ragging Committee for the academic year 2025-26

In strict compliance with the University Grants Commission (Curbing the Menace of Ragging in Higher Educational Institutions) Regulations, 2013, and to ensure a ragging-free environment on campus, the Anti-Ragging Committee of Sarojini Naidu Vanita Pharmacy Maha Vidyalaya is hereby constituted with immediate effect. The institution maintains a zero-tolerance policy towards ragging in any form.

1. Objectives of the Committee: The Anti-Ragging Committee shall serve as the principal body responsible for:

- Monitoring and ensuring that the institution is free from all forms of ragging activities.
- Developing and enforcing anti-ragging policies, rules, and guidelines within the institution.
- Addressing and resolving complaints related to ragging in a fair, impartial, and timely manner.
- Promoting awareness about the negative impact of ragging and the legal consequences among students, staff, and parents.
- Recommending appropriate disciplinary measures against offenders in line with institutional and legal frameworks.
- Designing strategies and action plans for curbing the menace of ragging in the University by adopting an array of activities.

2. Definition of Ragging: Ragging constitutes any disorderly conduct, whether by words spoken or written or by an act, which has the effect of teasing, treating, or handling with rudeness a fresher or a junior student. It includes indulging in rowdy or undisciplined activity that causes or

is likely to cause annoyance, hardship, or psychological harm or to raise fear or apprehension thereof in a fresher or junior student, or asking students to do any act or perform something that such students will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or junior student.


