- Students were briefed on UGC Anti-Ragging Regulations and the legal consequences for offenders, including suspension, fines, and criminal charges.
- Emphasis was placed on student safety and legal protection for victims.

3.4 Role of the Anti-Ragging Committee

- Members introduced themselves and explained their roles in ensuring a safe campus.
- Students were provided with contact details of committee members and available helpline numbers.

3.5 Reporting Process

- Step-by-step guidance was given on how to report an incident confidentially.
- Multiple reporting channels were highlighted:
 - Anti-ragging helpline
 - Email support
 - Committee office
 - College mobile app/website (if applicable)

3.6 Student Interaction

- Students actively asked questions regarding safety measures, hostel environment, and grievance procedures.
- Committee members assured full support and confidentiality in handling complaints.

4. Decisions Taken

- Continued monitoring during the induction period and throughout the academic year.
- Display of anti-ragging posters in key areas of the campus.
- Circulation of an online anti-ragging undertaking for all students.
- Schedule follow-up awareness sessions.

5. Conclusion

The meeting concluded with a reaffirmation of the institution's commitment to maintaining a safe and inclusive environment. Students were encouraged to stay vigilant, support each other, and report any concerns without hesitation.

Introduction

An **Anti-Ragging Awareness Programme** was organized by Anti-Ragging committee members SNVPMV as a part of the **Induction Programme for First-Year B. Pharmacy & Pharm.D students** on. The primary objective of this session was to create awareness among the new entrants about the seriousness of ragging, its legal implications, and to promote a healthy, respectful, and inclusive campus culture.

Objectives
