INTRODUCTION

The **Induction Programme for the newly admitted B. Pharm and Pharm. Post-break, an **Anti-Ragging Awareness Session** was delivered by **Dr. S. Hemalatha**, who sensitized the students to the anti-ragging laws and emphasized the zero-tolerance policy of the institution. This was followed by a detailed presentation by **Dr. S. Anuradha Bhai** on the **Internal Complaints Committee (ICC)**, highlighting mechanisms to ensure a safe, respectful, and inclusive campus environment for all students.

Following the morning sessions, students had a **lunch break from 12:00 PM to 1:30 PM**.

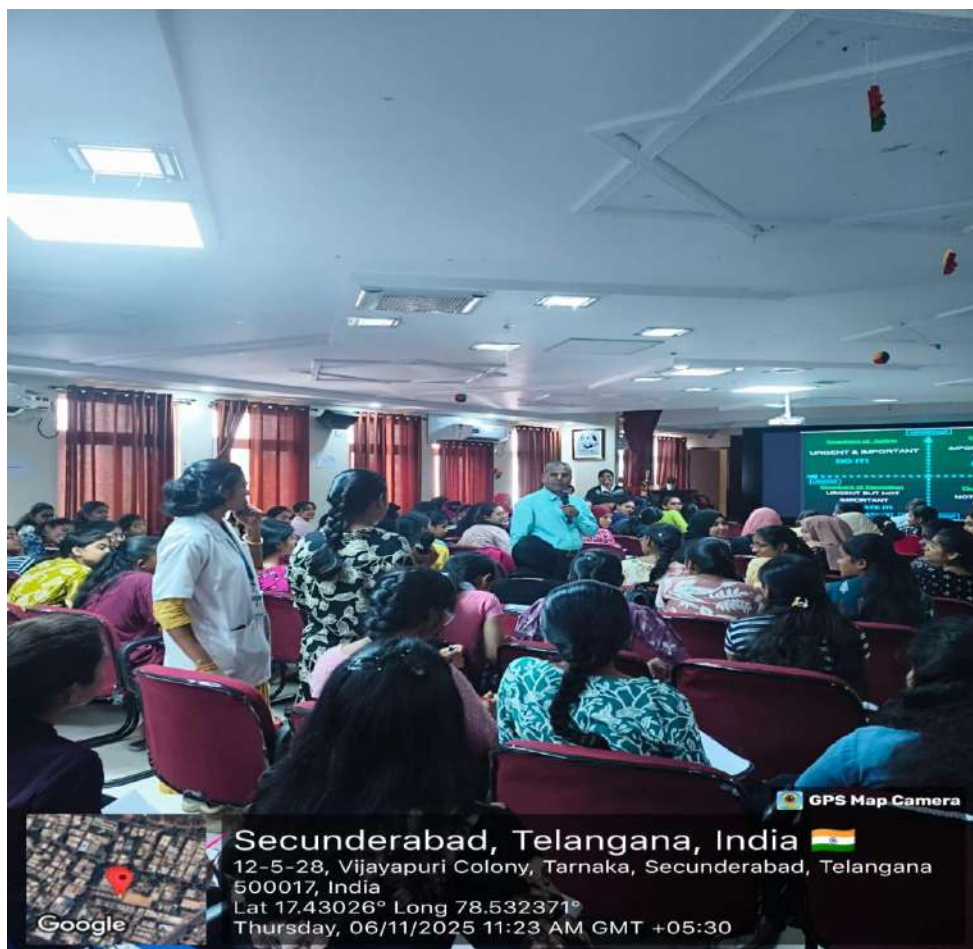

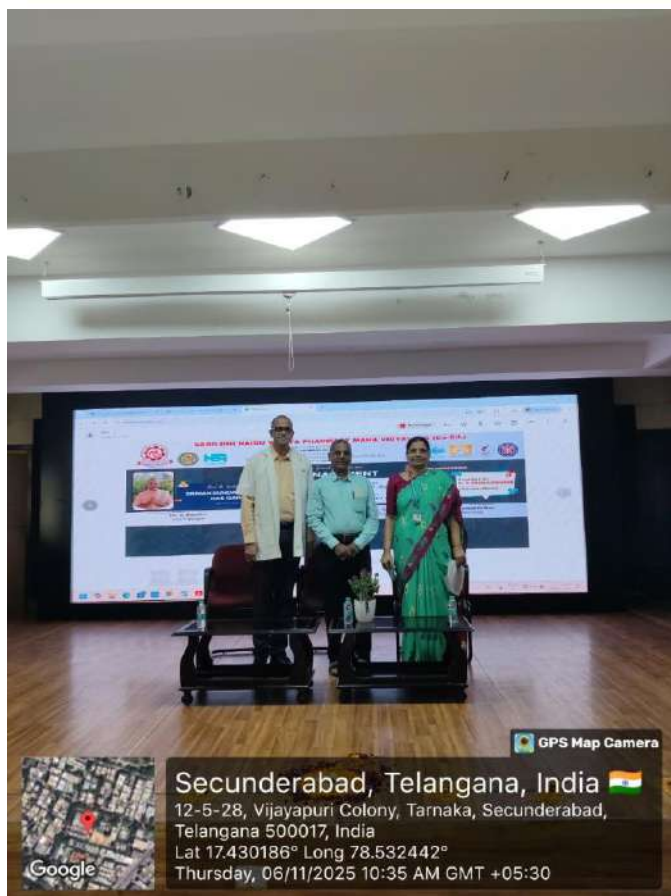
