### **Report on Higher Education Awareness & Strategy Session**

**For B. Pharm Final Year (VII Semester) Students**

Pharm Final Year (VII Semester)** students on **29th December 2025**. The speaker also discussed the availability of **scholarships, financial aid, and structured counselling support**, motivating students by clarifying how financial constraints can be addressed through proper guidance.
