### **Report on Anti-Ragging Committee Seminar**

**Topic: “Ragging Laws – Women Safety Issues & Initiatives of Government”**

The Anti-Ragging Committee of Sarojini Naidu Vanita Pharmacy Mahavidyalaya (SNVPMV), organized an impactful seminar on “**Ragging Laws – Women Safety Issues & Initiatives of Government**” on 27th June 2025.

The objective of the seminar was to raise awareness among students regarding the severe consequences of ragging, the legal framework to combat it, and the government’s proactive measures to ensure women’s safety and dignity in society.

The seminar began at **11:00 AM** in the college auditorium. The event was smoothly anchored by **Ms. Kanya** and **Ms. Loretta**, students of **Pharm D III Year**. The distinguished guests—**Dr. Pagadala Ashok**, Additional Deputy Commissioner of Police (North Zone), Hyderabad; **Dr. N. Srinivas**, Director of SNVPMV; and **Dr. S. Anuradha Bai**, Professor & Head of the Department of Pharmaceutical Quality Assurance and Coordinator of the Anti-Ragging Committee—were respectfully invited onto the dais, followed by a soulful **prayer song** rendered by **Ms. Tanmai**.

Dr. N. Srinivas, Director of SNVPMV, delivered the opening remarks. He emphasized the importance of maintaining a safe, inclusive, and respectful academic environment that upholds students' rights and well-being.

The guest speaker, Dr. Pagadala Ashok, Additional Deputy Commissioner of Police (North Zone), Hyderabad, was introduced. His vast experience in public safety and law enforcement brought valuable insights to the discussion.

Dr. Pagadala Ashok delivered an informative and engaging session on “Ragging Laws – Women Safety Issues & Initiatives of Government.” He explained the concept of ragging as a form of psychological abuse and intimidation, which can severely impact a student’s mental health.

Dr. Ashok then shifted focus to women's **safety issues, addressing domestic violence, cybercrime, harassment at the workplace, and public safety concerns**. He highlighted several Telangana police initiatives aimed at addressing social and financial vulnerabilities affecting women.

**Important government initiatives discussed included:**

**Nirbhaya Fund (2013)** for public safety infrastructure,

**Bharosa Centres** – support systems for women and children,

**One Stop Centre Scheme (Sakhi)** providing medical, legal, and psychological aid

Women Helpline 181, SHE-Box ([www.shebox.nic.in](http://www.shebox.nic.in)), and Cybercrime Reporting Portal ([www.cybercrime.gov.in](http://www.cybercrime.gov.in))

**He also introduced T-Safe**, a safety app for ride monitoring:

**Smartphone users:** Can activate safety monitoring via the T-Safe app or web link.

**Non-smartphone users:** Can use IVR by dialing 100/112 and selecting option 8.

**SOS Integration:** T-Safe is linked with Uber SOS and SafeGaadi; triggering the SOS shares real-time ride data with the police.

The speaker concluded with encouraging words, urging students to be vigilant, informed, and proactive in reporting and preventing any form of abuse.

The guest speaker, **Dr. P. Ashok**, was felicitated with a shawl, bouquet, and memento by the organizing committee as a token of appreciation and gratitude for his valuable contribution to the session.

The vote of thanks was proposed by **Dr. S. Anuradha Bai**, Professor & Head, Department of Pharmaceutical Quality Assurance, Coordinator anti Ragging committee, She extended heartfelt gratitude to the guest speaker, dignitaries, faculty members, and students for their active participation and support in making the seminar a meaningful success.

The seminar concluded with the **National Anthem**, leaving the audience with a sense of unity and collective responsibility toward building a safe and inclusive campus environment.
