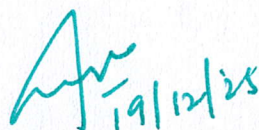

Following resolutions were the recommendations and approvals

1. It was resolved to recommend the constitution of Board of Studies with minor modifications to include student representatives from all three B.Pharm, M.Pharm and Pharm D Programmes.

2. It was suggested to include the schedule declaration of results in the Institutional Academic Calendar – 2026 for all the three programmes.
3. It was resolved to recommend the Scheme of instruction and Examination of B.Pharm, M.Pharm and Pharm D Programmes.
4. It was resolved to recommend the syllabus of First year of all the three B.Pharm, M.Pharm and Pharm D Programmes with minor modifications to include new courses titled “AI and Python Programming in Pharmacy” and “Professional Communication Skills” through rationalization of existing courses.
5. It was also resolved and recommended to encourage the students to study any foreign language additionally and NPTEL courses.
6. It was resolved and recommended to seek the approval Academic Council for Rules and Regulations for the three programmes B.Pharm, M.Pharm and Pharm D Programmes under the Autonomous stream.
7. It was resolved to recommend the Institute Vision and Mission Statements.
8. It was suggested to the institute to follow the procedures pertaining to conduct of Examinations (under Autonomous Stream) on par with Osmania University.
9. The Member Secretary thanked all the members for having attended the meeting and offering valuable suggestions
