2. Time limit:
 - Solo: **2-3 minutes**
 - Group: **3-5 minutes**
3. Participants may perform any genre unless otherwise specified.
4. Karaoke/instrumental tracks must be submitted before the deadline in MP3 format.
5. Live instruments are allowed only with prior approval.
6. Songs containing offensive or inappropriate lyrics are not permitted.
7. Exceeding the time limit may result in point deductions.

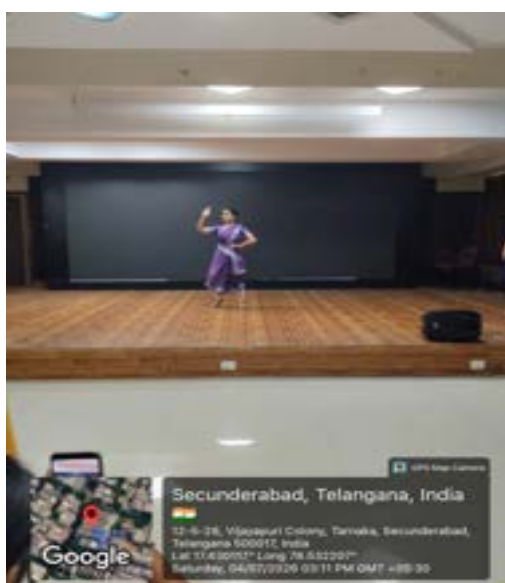
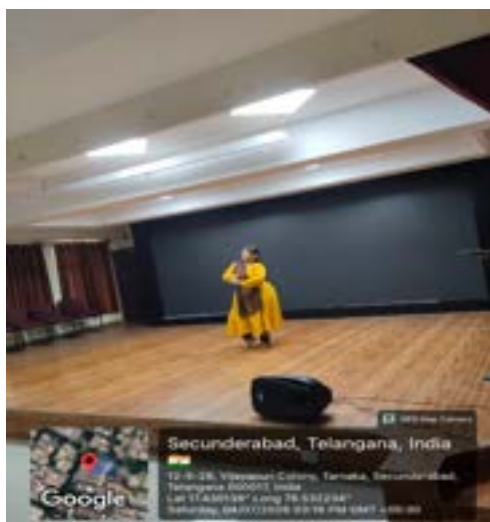
